### 7. TERMS & CONDITIONS AND SCOPE OF WORKS OF CONTRACT AGREEMENT. <u>GENERAL TERMS AND CONDITIONS</u>

- 1. The successful bidder should decide swimming pool membership charges/rates from non-club members and member of the club after the prior permission from Administrator/governing body.
- 2. Standard operational procedure regarding swimming pool in the morning & evening shift:
  - (a) International level medalist swimming player shall be allowed to use the swimming pool without paying any charges with the permission of club.
  - (b) In no condition there should be more than 70 members in the pool in any particular shift.
  - (c) The successful bidder will have to keep the equipment(s) in good condition.
  - (d) The successful bidder will be fully responsible for any mishap and safety of persons and maintenance of the swimming pool
  - (e) Separate timings for ladies and families shall be there.
- 3. During non-swimming hours the contractor shall have to clean the water with help of chemical doses, suction sweeper pumps, wire brushes, nets with handles, etc.
- 4. The successful bidder should give separate timings/ minimum 1 slot to club members or as per demand, which will decide by the club administrator /governing body.

- 7. The successful bidder shall display the timings, charges and safety and sanitary rules clearly at the reception desk for the members.
- 8. Electricity and water charges will be borne by the successful bidder from the date of award of contract.
- 9. No Liquor (except Eatable, Water and Soft Drinks) shall be permitted to be served to Guests/Members in the Swimming Pool/Reception area. No food/water/Soft drinks items shall be permitted from the outside.
- 10. The firm will issue i-cards to all the members and maintain the record for every entry as the management can check all the records any time.
- 11. The successful bidder will regularly maintain, clean and keep the whole area insect/rodent free, with regular use of cleaners/disinfectants in wash rooms.
- 12. Manager/Management committee of the club may, from time to time, inspect the premises and the swimming pool to ensure that required number of manpower is deployed/placed by the successful bidder, failing which the disciplinary action will be initiated against the successful bidder.
- 13. Complaint regarding quality, overcharging, poor service and behavior of staff must be promptly attended.
- 14. The successful bidder will ensure that the contract or any part of the work is not sublet to any other party or individual without written permission of the management.
- 15. Ensure that day to day decisions of the Management is implemented/complied and all data, reports and records are made available to the office of Ambala Club if and when asked for.
- 16. The Management can inspect the Swimming Pool Area, Quality of Water, Cleanliness of the Deck Area and Washrooms any time.
- 17. The contractor shall deposit performance security of Rs. 15,00,000/- (Rs. Fifteen Lakh only) in the form of Bank Draft at the time of finalization of the contract. In case of any violation of any clause of the contract the administration of the club will be empowered to forfeit the amount of performance security deposited by the contractor.
